### We Need Your Support!

We greatly appreciate the support of our shipmates that have paid association dues for 2018 and beyond! However, the association could sure use some additional paid memberships.

As many of you may be aware, we had to switch to a new web site this year because the software for the old web site was no longer supported. We attempted to solicit assistance from our membership when switching to the WordPress software used on the new web

Site, but we were unable to find help. As a result, we have paid over \$5,000 to GoDaddy to help setup the new web site. Therefore, our association's funds are extremely low. We fund all our operating expenses with paid memberships and a small profit on Ship's Store sales, and we have experienced fewer paid memberships in 2018 than at any time in the past 14+ years.

**Blue Water Navy Vietnam Veterans Act**

The House Veterans Affairs Committee approved the Blue Water Navy Vietnam Veterans Act (H.R.299). This bill would clarify that servicemen serving off the coast of Vietnam during the Vietnam War have a presumption for filing disability claims with the VA for ailments associated with exposure to Agent Orange. The Blue Water Navy Vietnam Veterans Act has now been sent to the full House of Representatives for consideration. Members of FRA (Fleet Reserve Association) are urged to go online and use the FRA Action Center to ask their representative to support

this important bill.

As of July 13, 2018, the Senate Veterans Affairs Committee has scheduled a hearing on the House's version of the Blue Water Navy Vietnam Veterans Act. We will continue to monitor the movement of this legislation through Congress, and report on its progress in future newsletters.

send you an email with the total cost including shipping. You then have to mail me a check for the purchase, then my shipping the items when I receive your check.

Now when you select items and place them in the cart, the site will figure out the cost plus the shipping charges. Shipping costs are based on the weight of the items plus the zip code (or shipping zone) the purchase is being shipped to. All purchases are shipped by US Postal Service, and are shipped Priority mail. This method provides insurance and a tracking number.

Once an order is shipped, I will provide PayPal with a tracking number and indicate that the order was shipped. You will receive a notice from PayPal that the order was shipped, and they will provide you with the tracking number. I will send you an email to let you know the order was shipped, and when to expect arrival.

When placing an order, please make sure to properly fill out all information requested. Email address and phone number are important in case I need to contact you.

Orders are generally completed and shipped the same day I receive them. There may be times it might take a couple days, if this happens I will send you an email to let you know of the delay.

The web site automatically keeps track of the stock on hand. If an item is not in stock, it will let you know when you try to purchase it.

Please check out the new ship's store. New items will be added after the reunion in September. Reunion attendees will be given the first shot at the new items.
